



# LOGISTICS DEPARTMENT STRATEGY



01

First ask our Customers to send soft copy of the documents by mail (invoice, packing list, certificate of origin) to make sure that all the documents are matching with the Egyptian customs system.



02

Once receive the original documents, our team start the clearance process and keep follow up with custom till release the container to our warehouse or customer warehouse.



03

When our warehouse team receive the container, they handle the offloading , storage and prepare arrival report mention actual quantity received, compared with invoice quantity, review the variance if have, then update the ERP system with stock

# FINANCE DEPARTMENT STRATEGY

- 01** Once confirming the soft copy of documents, we Calculate the estimated Form 4 fees & customs value according to imported goods HS code to arrange the required capital before shipment arrive .
- 02** After receiving the original documents, send to bank to issue required forms and stamp the documents in no time, maybe 2 hours.
- 03** Follow up with logistic team to arrange customer payment on time to avoid any delay in releasing the shipment.
- 04** Calculating all cost for the shipments till we receive it in our warehouse (including Clearance expenses , Trucking expense, Freight , storage, demurrage, GOIEC Fees, customs ,bank charges)
- 05** Calculating the cost per unit and update our accounting system with value and quantity of the inventory.
